

# Avalik kiri elusloomade pikamaatranspordi korraldajale Stena Line Limited

18 loomakaitseorganisatsiooni, sh **MTÜ Loomus**, saatsid ühise avaliku kirja ettevõttele Stena Line Limited, mis korraldab elusloomade pikamaatranspordi ning on järjepidevalt demonstreerinud, kuidas nad väärkohtlevad loomi, sh võõrutamata vasikaid.

## **Kokkuvõte (inglisekeelne originaalkiri on dokumendi lõpus):**

25. juulil 2024. aastal saadeti Stena Line'i tegevjuhile Niclas Mårtenssonile avatud kiri seoses võõrastamata vasikate transpordiga Rosslare-Cherbourgi marsruudil. Transport on jätkunud hoolimata Euroopa Komisjoni hinnangust, et see rikub ELi loomade heaolu käsitlevaid õigusakte. Kirjale kirjutasid alla 24 valitsusvälist organisatsiooni ja siiani pole vastust saadud.

Kiri polnud ettevõttele esimene seda tüüpi teade – sellele on eelnenud aastate kaupa kohtumisi, e-kirju, petitsioone ja proteste ning meedias on kirjutatud palju artikleid, mis toovad esile tööstuse julmuse ja seaduste eiramist. Petitsioone on Stena Line'ile esitatud suurel hulgal, mis tõestab, et paljudele Euroopa kodanikele on teema südamelähedane, samas pole ettevõtte kuidagi positiivselt reageerinud. 2022. aasta juulis algatas Ethical Farming Ireland kohtumenetluse Iiri riigi vastu seoses võõrutamata vasikate ekspordiga ning hetkel on juhtum pooleli. Stena Line on olnud lahutamatuks konfliktiga seotud.

Rosslare-Cherbourgi liinil sõitval Stena Horizon parvelaeval transporditud vasikate väärkohtlemise ja näljas hoidmise paljastas 2023. aastal Iiri saade [“RTÉ Investigates” episoodis “Dairy’s Dirty Secret”](#) (“Piimatööstuse räpane saladus”). Samas saates on uuritud ka parvelaeva Stena Vision, mis on samuti tugevalt seotud võõrutamata vasikate väärkohtlemisega ning on teada juhused, kus Euroopasse viidavad vasikaid transporditi lisreali.

Stena Line toetab ebainimlikku tööstust, mis on vastuolus nende kultuuriliste ja jätkusuutlikkuse eesmärkidega. Kui Stena Line lõpetaks võõrutamata vasikate transportimise, sunniks see piimatootjaid alternatiive otsima, mis aitaks kaasa kõrgemale heaolule ja säästvamatele tavadele. Isaste piimavasikate jaoks on palju muid võimalusi ja tegelikult eksporditakse neist vaid väike osa. Sellest hoolimata kogevad sõidutatavad vasikad märkimisväärseid kannatusi. Tööstus ei muutu, kuni seda toetab Stena Line ning neid kutsutakse üles tegema seda, mis on loomadele ja keskkonnale hea, selle asemel, et jätkata avalikku vaidlust.

**Loomade eestkoste organisatsioon Loomus leiab, et elusloomade pikamaa transport tuleb lõpetada, sest**

- loomade heaolu pikamaa transpordil ei ole võimalik tagada olenemata sellest, kui ranged piirangud sellele peale panna;
- EL elusloomade transporti käsitlevates andmetes on tõsised lüngad, mis näitab, et järelevalve ja võimalus tagada, et heaolu on tingimustest on kinni peetud, on sisuliselt võimatu.

Rõhutame, et loomade vedamise üldtingimuste esimeses punktis on kirjas, et loomi ei ole lubatud vedada ega lasta vedada viisil, mis põhjustab või võib neile tõenäoliselt põhjustada vigastusi või tarbetuid kannatusi. Sellest punktist tulenevalt ei tohiks elusloomade pikamaa transport üldse kõne alla tulla olenemata, mis tingimustel seda tehakse.

Dear Mr Mårtensson

On 25<sup>th</sup> July 2024 an open letter was sent to you, by post and email, over concerns that Stena Line continues to transport unweaned calves on the Rosslare to Cherbourg route, despite the European Commission's assessment that the trade is being carried out in breach of EU animal welfare legislation. The Commission concluded that the calves are not being fed within the required timeframe, following an audit conducted in June 2022<sup>1</sup>. The letter was signed by 24 NGOs and to date no reply has been received.<sup>2</sup>

The letter has been preceded by years of meetings, emails, letters and petitions, by several NGOs from differing member states, along with several protests at Rosslare port. There have been many articles in the news highlighting the cruelty of the industry and non-compliance with legislation and official complaints to the European Commission – see Annex below. In July 2022 Ethical Farming Ireland launched legal proceedings against the Irish State in relation to the export of unweaned calves and the case is ongoing. Stena Line has been inextricably linked with all the controversy at every stage.

There have been meetings with NGOs at the Stena Line head office in London: one in 2019, and the most recent on 30<sup>th</sup> September 2024, that was attended by Ian Hampton and representatives from Dyrevernalliansen, Four Paws and Ethical Farming Ireland. At both meetings a petition was submitted to Stena Line signed by many thousand members of the public from across Europe.

A further petition was delivered in November 2020 at an online meeting with Stena Line representatives, attended by Eyes on Animals and The Swedish Association for the Protection of Animals, with over 22,000 signatures. It is clear that this subject is of great concern to many citizens across Europe, but unfortunately there have been no positive outcomes following any of the meetings or petition deliveries.

In March 2021 Ethical Farming Ireland submitted a formal complaint to the European Commission, stating that Stena Line is transporting unweaned calves from Ireland to continental Europe in ways that breach Regulation 1/2005, that the Irish Authorities have failed to take appropriate steps under Article 26.4 of Regulation 1/2005 in respect of those breaches, and in particular has failed to take steps to prevent recurrence of the breaches by Stena Line. The complaint was not upheld, but only because the Commission claimed no evidence had been provided to show calves are not being fed during the ferry journey. Now that the Commission has obtained evidence through it's own audit, Ethical Farming Ireland submitted a further complaint that is still under review. Dutch NGO Eyes on Animals has also submitted a formal complaint.

An article was published in Belfast Live in May 2021 following the first complaint to the Commission.<sup>3</sup> There are a number of quotes from a Stena Line representative including stating it "will only allow the continued transportation of livestock on its vessels, if EU requirements are met and the sector improves the welfare of livestock." EU requirements are not being met, and the welfare of unweaned calves during the journey from Ireland to France has not improved. The spokesperson said: "Stena Line takes its duty of care for the welfare of live animals very seriously." However, the actions by Stena Line do not match these words. The European Commission has concluded from the audit conducted in June 2022 that these journeys are not in line with legislation, yet Stena Line continues to transport calves.

In July 2023 Irish television broadcaster RTÉ Investigates aired 'Dairy's Dirty Secret' exposing cruel practices in the calf export industry, abuse at Irish marts and extended periods with no feed during the gruelling ferry journey from Rosslare to Cherbourg. The programme featured the Stena Horizon ferry boat, linking the company to very significant suffering of young and vulnerable animals.

In October 2024, RTÉ Investigates again exposed highly abusive treatment of unweaned calves in their programme 'On the Hoof,' this time featuring the Stena Vision. The programme included evidence that calves transported to Europe, via Stena Line, have ended up being shipped to Israel. Once again Stena Line is inextricably linked to animal suffering.

Stena Line is propping up an unsustainable and inhumane industry, which is at odds with your sustainability and cultural goals. If Stena Line stopped transporting unweaned calves, dairy farmers would be pushed into seeking alternatives for their calves, which would help lead to higher welfare and more sustainable practices. There are many other options for male dairy calves and in fact only a small percentage are exported. Nonetheless, those that are exported experience poor welfare and significant suffering. The industry will never change while it is supported by Stena Line.
